# How To Use This Guide

It is important to note that this brochure is not intended to be a comprehensive guide. Rather, it is meant to be an *introductory* resource explaining protective orders in the state.

This tool is not designed to provide legal advice or suggest that obtaining a protective order is a survivor's best course of action. It is an informational resource to consider in addition to other options available to a survivor. **Ultimately, the decision to pursue a protective order is the survivor's decision.** This guide is intended to assist survivors in making an informed decision about whether to file for a protective order. It is strongly recommended that individuals work with victim services, legal advocates or other support systems.

# What Are Protective Orders?

A protective order is a court-issued document that can provide relief and resources.

#### Protection From Abuse Order (PFA)

For those that are currently or were previously in a substantive<sub>1</sub> dating relationship, married, or in a familial relationship, a PFA Order instructs someone to stop abusing another person and may include additional measures like keeping the abuser away from the victim. Abuse encompasses various forms of harmful behavior. There are emergency or "ex parte" same-day hearings, and final hearings. These can result in one-year, two-year, lifetime orders, or no orders.

1. Neither a casual acquaintanceship nor ordinary fraternization between two individuals in business or social contexts shall be deemed to constitute a substantive dating relationship as defined in 13 *Del. C. §* 1041.

# Sexual Violence Protective Orders (SVPO)

For those not in a family or substantive dating relationship, SVPOs protect individuals who have experienced sexual violence. It offers specific protections to the victim, for example, prohibiting the offender from contacting or approaching them, and may include additional measures to ensure their safety. There are emergency or "ex parte" sameday hearings, and non-emergency orders must be held within 15 days of filing.

# Lethal Violence Protective Order (LVPO)

An LVPO prohibits a person from controlling, owning, purchasing, possessing, or having access to a firearm to prevent potential acts of lethal violence. The order grants specific restrictions, to ensure the safety of potential victims and mitigate the risk of lethal violence. Law enforcement officers request emergency orders and nonemergency hearings are held at Superior Court within 15 days of filing.

#### **Protection From Abuse Order**

# Who can file?

- ✓ Division of Family Services on behalf of a minor child in its care.
- ✓ Division of Adult Protective Services acting in the interest of an impaired adult.
- A person from a "protected class" who files allegations of domestic violence which includes:
- ✓ Spouse or former spouse
- ✓ Persons living together and holding themselves out as a couple (with or without a child in common)
- Persons living separate and apart but who have a child in common
- ✓ Persons in a current
   or former substantive
   dating relationship
- ✓ Parent or child (including step- and in-law)

#### Who can provide support?

#### Domestic Violence Advocacy Program (DVAP)

Located in Family Court at the courthouses in New Castle, Kent, and Sussex Counties. Provides support to people experiencing intimate partner violence, domestic violence, and dating violence, but not other forms of family violence.

# ✓ Brother or Sister (including step- and in-law)

- ✓ Son or daughter (including in-law and where parental rights have been terminated)
- ✓ Grandparent or Grandchild
- ✓Any other family member you are related to by blood, adoption, or marriage but only if you reside "in one home under one head."

## **Sexual Violence Protective Order**

# Who can file?

- ✓ Petitioners who do not qualify for a PFA because there is no family or substantive dating relationship between the victim and perpetrator and where the respondent is at least 18 years of age.
- ✓ The petitioner experienced any non-consensual sexual conduct or non-consensual sexual penetration₂.
- ✓ The petitioner must have a reasonable fear that the respondent will harm the petitioner in the future based on specific conduct that occurred simultaneously with or subsequent to the sexual violence.

2. See 10 Del. C. § 7202 for a definition of sexual conduct and penetration.

## **Lethal Violence Protective Order**

# Who can file?

#### ✓ Emergency LVPO

The concerned individual must contact their local police department with jurisdiction. <u>Only law enforcement can</u> <u>petition for an Emergency LVPO.</u>

#### ✓ Non-Emergency LVPO

Family members, persons with a child in common, persons in a substantive dating relationship, or law enforcement can petition in Superior Court.
